Dr. Carl Ellison D.Min. has taken pity on this poor "information starved" editor, and graciously provided a few of the 21,000 pages of Genealogical information he has compiled over the years. See "Carl's Corner." Carl's first column has information on some of the descendants of Robert Anderson, our Anderson County namesake.

Some of the newspaper articles are from an earlier time. While not as full of local news as the 1890 editions, they are much easier to read. Newspaper articles used to date are from microfilm in the Anderson County Library. The 1893 editions have become almost unreadable, thus the switch. The 1846 newspapers are full of Sam Houston and our War with Mexico and while I would love to include some of these articles, space does not permit. I do plan to continue to include as much local history as possible.

Our Society has secured a climate controlled storage site for the Chapter's publications at a cost savings of \$300 a year through the generosity of **Debbie Price**, who has volunteered the use of a spare room. See the back page of this newsletter, if you have not purchased your copies. The Pendleton District Historical Commission is now displaying our publications for sale in Pendleton.

He was burnt out on the 9th of April, 1845,—commenced clearing a yard to make brick on the 15th of May, and he had the brick made and built his large hotel on the southwest corner of the public square, on the spot where the old one stood, which took 530,000 brick to complete, and contains about 36 comfortable rooms, and was opened on the 19th of March, 1846

Celebration of the 4th of July at Anderson CH

The fourth of July was commemorated . . . at the spring of Capt. J. P. Benson, in a style and spirit befitting the occasion . . . Capt. Wilkes, marshal of the day, conducted the assemblage at the Presbyterian Church, where they had convened at the ringing of the bell, . . . The Rev. J. C. Chambers offered an appropriate prayer. . . The Declaration of Independence was read by Mr. Wesley Leverett Charles J. Elford, Esq. of

Greenville then addressed the audience . . . Gen. J. N. Whitner, President of the day, then introduced Mr. Robert H. Reid of the South Carolina College, who made an address in favor of temperance . . . The President of the day announced toasts by the following:

Anderson Intelligencer February 22, 1893. The Bribery Case

On Friday afternoon of last week Solicitor Ansel read the affidavits below published immediately after court was called. A large crowd was in the Court House, and everybody was startled at the facts set forth, and eagerly listened as the reading proceeded. It was very evident that his honor, Judge Izlar, was deeply interested, and that his wrath was kindled against the guilty. The following are the affidavits:

STATE OF SOUTH CAROLINA, County of Anderson.

Personally comes before me J. W. Dillingham, who . . . says, That on Monday night the 13th inst. near 10 o'clock at night, B. P. Trammell came up to the deponent and said, "I will tell you something if you will say nothing about it" and deponent said "What is it?" He replied, "I am employed to work this Jury for Sullivan. A Mr. Harper came to me in front of Hotel Chiquola and took me up into a room and gave me two thousand dollars" and Trammell took deponent by the hand and placed deponent's hand on his hip pocket, and said "The money is here." and deponent felt a large roll, which deponent supposed to be the money: and Trammell said "I am a good one, and already worked one juryman, and he has the money and a quart of liquor and has gone home." Deponent asked him who that was and he replied, "Ed Cashine, I've got him I know, and I gave Leak \$100 to keep him and I know I have got him;" and also replied, "I will work Norryce if I can. I will try." Previous to this conversation deponent saw Trammell and one of said jurymen at Leak's Barroom together, and Trammell ask deponent if deponent saw anything, and deponent replied, "I saw you give him money."

On the following Tuesday evening deponent communicated to the Chief of Police the conversation had on the previous evening with Trammell, and the matter was communicated to Mr. Prince, who came to deponent to know the facts. By instructions of the chief of police and Mr. Prince, deponent carried Trammell to a place where the Chief of Police, Mr. Prince and others might hear it for themselves. Deponent and Trammell went into a hallway leading into the council room on Brick Range in the City of Anderson, near to an open adjacent room where the chief of police was stationed and there Trammell repeated the conversation as set forth in the affidavit of C. F. Jones, which I have heard read. The next morning, deponent call upon Trammell for the check, and he said "alright." at first, and started with deponent to the Farmer's and Merchant's Bank and stopped and said "I will have to see some other parties," naming a Mr. Harper. He came back after awhile and said "That party is worked I think and I can't do that."

Personally came before me C. F. Jones who, ... says, That on the evening of 14th inst. deponent was near by and heard a conversation between B. P. Trammell and John Dillingham, and heard Trammell tell said Dillingham that he, Trammell would bring him a check for \$100, if said Dillingham would get a certain Juryman on the side of Sullivan in the case pending against Sullivan. Mr. Dillingham stated he thought he could work certain parties from Williamston, and there were other Jurymen he thought he could work, and Trammell replied, "That is good," and he would bring

him a check. A certain Juryman's name was called, and Trammell replied that he, Trammell, had already fixed him. He also named another Juryman, and Dillingham said, "I can get another Juryman for you." and Trammell replied, "He is a good one," and I will have you the check, and I've the thing as sure as there is a world," and Dillingham said, "Did you work Cashine?" and Trammell said, "yes, Cashine is a dandy."

He did not state who was furnishing the money. His conversation was in reference to the case of the State vs. Sullivan.

Dillingham reported a conversation between himself and B. P. Trammell, both of whom are on the Deponent immediately police force. communicated the matter of G. E. Prince, Esq., and it was arranged to hear the matter direct from Trammell, when deponent C. F. Jones and G. E. Prince were stationed so that they might hear the conversation. Deponent has heard and read the foregoing affidavit of C. F. Jones and concurs in the statements thereof as being substantially the conversation and statements of B. P. Trammell as to his actions in the matter and case referred to.

Personally came before me E. T. Cashine who. . .says, That he is a Juror serving at this the February term of the Court of General Sessions for Anderson County, State aforesaid. That a few evenings since, about the 13th or 14th inst., he was met on Depot Street in Anderson by one B. P. Trammell, a policeman in the City of Anderson, who invited deponent into a barroom to take a drink with him. That while with him said Trammell brought up

the case of the State vs. Sullivan and stated that deponent had been inquired about to know how deponent would do if put on the jury in said case, and wanted to know if deponent was open to influence or not. He requested deponent to return at night and talk the matter over. Deponent replied he would be governed altogether by the evidence in the case if he were drawn as a Juryman in said case, and with that reply left Trammell.

On hearing the above affidavits read Judge Islar on motion of the solicitor, issued a rule against B. P. Trammell to show cause on the following morning why he should not be adjudged in contempt of the Court and punished for attempting to corrupt and bias and influence Jurors at the sitting of this Court. Copies of the above were served on Trammell.

Anderson Intelligencer May 31, 1893

A destructive tornado . . . passed through the Holland Store neighborhood and injured the dwellings of Messrs. A. B. Sullivan, A. F. Shearer, T. D. Stevenson, And Mrs. Wakefield. Nearly all the outbuildings on these places were blown down. Crops, orchards and forests were badly injured. . . . At Starr the terrific force of the storm had not Mr. Doc. Jones dwelling and outhouses were completely wrecked and his store badly damaged. A wagon spoke was driven through a six inch seasoned post, and this evidence will be put on exhibition in this city for a few days and perhaps sent to the World's Fair. There were some twenty or more tenant houses blown to pieces on Mr. P. B. Allen's place. . . . The top was blown from Mr. Allen's barn, and of 1000 bundles of fodder stored there not one was left. The loss of Messrs. Allen, Iones and Stevenson has been estimated at \$1000 each.

After leaving Starr, the next place we hear of the work of the devastating winds is on the plantation of Mr. Dolph Jones. In Hall Township, the gin house on Mrs. Lizzie Long's plantation was blown down and two good buggies smashed to pieces. On Mr. George Long's plantation a tenant house was lifted off it's pillars and turned completely around. Mr. S. F. Finley's gin house and a buggy was smashed. The dwelling house of Mr. John Finley was partly unroofed and one chimney blown down. . . . Mr. George Schrimp's dwelling house was badly damaged. . . In the section of Varennes Church, several outhouses of Mr. Vance McGee were smashed. At Mr. Joe Parker's home the stables were blown down but his stock were not hurt.
