In the last quarterly we started to publish the answers to Philip Cheney's requests to some states about the availability of their name index to death certificates. The following will continue that report:

Arkansas Department of Health, Division of Vital Records, 4815 West Markham Street, Slot 44, Little Rock, AR 72205-3867. "Only Arkansas deaths are recorded in this office. There are no original death records for events which occured before February 1, 1914. The fee is \$4.00 for the first copy and \$1.00 for each additional copy of the same record ordered at the same time. The fee must accompany the application. Send check or money order payable to the Arkansas Department of Health. Do not send cash. Only the names and dates listed will be searched for the \$4.00 fee. Names and/or dates submitted later will require an additional \$4.00 non-refundable fee."

Department of Health, State Office of Vital Statistics, P. O. Box 210, Jacksonville, FL 32231-0042. "The Office of Vital Statistics will sell microfiche indexes for the same price we purchase them with the exception of the one time processing/postage/miscellaneous fee of \$33. Following is a breakdown of the years available, number of microfiche, unit price for production and cost per set. Cost is determined by actual cost charged to Vital Statistics for the previous fiscal years untilization divided by the final cost and is updated every September by the Department of Children and Families Technology Center.
