His daughter, **Mary Stephens** was born May 8, 1927 in Anderson County, SC, but the family moved to Lyman, SC when Mary was less than a year old. ## OPEN LETTER TO KEEPERS OF THE GENEALOGICAL FLAME

**Dear Friends:** 


I am pleased to announce that the Confederate history project has been expanded to include soldiers who served from the Anderson District of South Carolina. This enlargement of the scope of my research enterprise will allow coverage of all the geographic area within the westernmost tip of the state, which presently includes the counties of Anderson, Oconee and Pickens (the Old Pendleton District). This research undertaking has also been given a new title, CONFEDERATE SOLDIERS OF SOUTH CAROLINA'S GOLDEN CORNER: ANDERSON AND PICKENS DISTRICTS, 1861-65.

Eventually, I hope to be able to disseminate preliminary lists of Anderson District's Confederate soldiers—just as the names of troops from Pickens District are currently being published in the OPD Newsletter. If you know of men who served in the Confederate States Army from Anderson District, I hope that you will let me know about them and share with this project whatever biographical information you might have concerning those soldiers.

Thus far, information has been collected about more than 3,000 Confederate soldiers from Pickens District (present-day Oconee and Pickens counties). But searches are still ongoing for additional data pertaining to some of those men. With the addition of soldiers from Anderson District, the total number of subjects in this project might very well ultimately exceed 5,000 men, all of whom served as Confederate soldiers from the Golden Corner of South Carolina.

In order to prepare biographical sketches of soldiers, the following facts are needed about each of them: complete name; birth and death dates; place of burial; names and dates of parents; name(s) and dates of wife/wives; names and dates of all offspring, as well as those of their spouses; date and place of entry into military service; name of the military unit(s) in which service was performed; any promotions and wounds received while in service; date and place of discharge from service; and any additional facts that ought to be included in the soldier's biographical sketch.

I realize, of course, that few readers of this letter are likely to have all of the above-listed needed data about any individual soldier. But whatever relevant information readers might have—and are willing to share—will certainly be welcomed and appreciated.



My sincere gratitude is expressed to the hundreds of members of OPDSCGS and other helpful persons who have already provided useful information. I am sure that many Confederate ancestors would be quite proud of their descendants and relatives who have helped to preserve family history and heritage. We should all bear in mind that love of their homeland guided and sustained most Confederate troops during their desperate defense of the South. My project is designed to honor those brave men who served from our area and to keep their military duty in remembrance. Please help me if you are able. Thank you very much.

J. M. Bailey served in Co. B (Palmetto Riflemen), 4th S. C. Wolunteers (Inf.), C.S.A., and died of disease during the Civil War.

Albert Baker was a member of Co. I, 14th S. C. Volunteers, C.S.A. He attended the first reunion of the company at the home of J. B. Moseley of Lowndesville, South Carolina on September 2, 1896.

Joseph McCrackin served as a private in Co. K, 2nd S. C. Rifles (Moore's Regt.)

Ewell E. Herron (d. 1863) was a member of Co. F, 24th S. C. Volunteers (Inf.), ir which he served as a private. He died of disease in September 1863 during the Civil War.

John Clayton Hickman enlisted in Co. C, 4th S. C. Volunteers (Inf.) at Anderson S. C. on April 14, 1861.

Samuel Porter Hillhouse was a sergeant in Co. I, 2nd S. C. Rifles (Moore's Regt.)

Thomas F. Wright (1841-1922) served in Control L, Jenkins Brigade, C.S.A. He was laid to rest in the cemetery at Townville Baptist Church.

David Josephus Sherard (1835-1912)

Company B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.), C.S.A., and Co. C, Palmetto Sharpshooters, C.S.A. (Drawing by Charles II. Busha) J. R. Tripp enlisted as private in Co. D, 4th S. C. Volunteers (Infat Camp Pettus, Virgin on August 1, 1861. He was from Anderson Dissouth Carolina.

## **DEATH OF MANSON JOLLY**

The news will be received with regret by the many friends of this bold and daring Confederate soldier. We learn that a private letter has been received, stating that Manson Jolly was drowned on the 8<sup>th</sup> of July near his home in Texas. He was building a residence on the opposite side of the creek from where he lived, and had crossed over on horseback several times during the day. The stream was greatly swollen, and in attempting to cross for the third or fourth time, he was carried with his horse down the creek, and in the struggle which ensued both were drowned. Mr. Jolly had been married about one year, and leaves a young wife, the daughter of a former citizen of Anderson.

The thrilling exploits and adventures of Manson Jolly in this section of the country, immediately after the war closed, are fresh in the recollection of all. His name was a terror for a long time to the garrison of United States soldiers, especially the volunteer white and colored regiments stationed at this place. When the regular troops arrived, he removed to Texas, where he has since been leading a quiet and peaceful life.

Preston Lewis Adams (1825-1906)
enlisted in Co. F, 24th S. C.
Infantry Battalion in 1862 and
was discharged at Murphysboro,
N. C. in 1865. On 14 Sept 1870
he married Sarah Ann Prince.

James F. Griffin enlisted in Co. J 4th South Carolina Volunteers (Inf.) at Anderson, S. C., on 14 Apr 1861; discharged by order of the surgeon general 24 Sept 1861 at Richmond, Virginia.

R. Mc. Cunningham, a member of Co. F, 24th South Carolina Infantry Battalion, C.S.A., was killed in the Battle of Chickamauga, GA.

J. A. McAlister, a private in Co. F, 24th South Carolina Infantry Battalion, died of disease in the spring of 1864.

James Blanchett served in Co. I, 14th S. C. Volunterrs; he attended the company's first reunion which was held 2 Sep 1896 at the home of J. B. Moseley in Lowndes-Ville, South Carolina.

Oliver "Duck" Bolt (1847-1922) was a native of Laurens County, S.C. and a son of Asa Bolt (1808-1876) and Hannah A. Bolt. He enlisted in the Confederate States Army at the age of seventeen years in 1864.

## Additional Facts About "Manse" Jolly

Manson Sherrill Jolly (1841-1869), the ex-Confederate soldier who has been described as an "unreconstructed rebel" and who acquired the nickname "Manse Jolly," was born on a 300-acre farm in the Lebanon community of Anderson District, S. C. He was one of the eleven offspring of Joseph Moorhead Jolly and Anna Cole (Sherrill) Jolly. On February 5, 1861, he enlisted at Pendleton, S. C., in an infantry regiment organized by William Butler. Later, during the Civil War, he served with distinction as a first sergeant in Co. F, 1st S. C. Cavalry. Six of Jolly's brothers also served in the C.S.A., and five of them were killed during the war. The sixth brother committed suicide shortly after the war. In the fall of 1866, Jolly went to Texas, where two years later he married Mildred Elizabeth "Millie" Smith (1847-1924), a daughter of John Gray "Lightning Jack" Smith (1825-1880), who was a native of Anderson District, S. C. Jolly and his wife had only one child, Ella Manson Jolly, who was born in Robertson County, Texas in 1869, shortly after her father's accidental death---which was reported in the newspaper article reprinted above.

Charles Loafer served in Co. E, 20th S. C. Volunteers, C.S.A. He attended the August 1914 reunion of the company at Neals Creek Church in Anderson County, South Carolina.

Hut Loftis was a member of Co. I, 14th S. C. Volunteers, C.S.A. He was living in September 1896.


O. B. Campbell died in a military hospital in 1864. He was a member of Co. F, 24th S. C. Volunteers (Inf.), C.S.A.

R. P. Brayram was captured by Union troops at Shipp's Gap, Georgia, and he died in a prisoner of war camp in the spring of 1865. He had served as a corporal in Co. F, 24th S. C. Volunteers, C.S.A.

Enoch Breazeale (1837-1917) was a son of Kennon Breazeale. He served in Co. B, 37th Virginia Cavalry (Bn.), in which he enlisted at Richmond, VA, on April 15, 1862. He probably had served previously in another unit.

A. B. Sargent enlisted as a private in Cq. D, 4th S. C. Volunteers (Inf.), C.S.A., at Camp Pettus, Virginia, 1 August 1861. He died of interitis at Richmond, VA.

John Patrick Shirley of Anderson
District; SC, served as a private
in Co. K, 3rd S. C. Infantry, C.S.

Nathaniel Amaziah Shirley was a sergeant in Company E, 20th S. C. Inf.

D. B. Sloan served in Co. E (Palmetto Riflemen, 4th S. C. Volunteers (Inf.), C.S.A. He was trans ferred to another command during the Civil War.

4th South Carolina Volunteers (Infantry), C.S.A. He was wounded in action and promoted to major.

Gaddis W. Farmer was a private in Co. D, Hampton Legion, C.S.A.

T. C. Featherston served in Co. B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.), C.S.A., in which he enlisted at Columbia, SC, on 9 May 1861. He was killed in battle.

Joseph C. Darricot was a member of Co. B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.), C.S.A. He survived the war and was paroled in 1865 by Union troops.

Edward N. Emerson was born about 1832. He enlisted in the army at Anderson, SC, on 14 April 1861. He was reported on his unit's muster roll of 31 Aug 1861 as having been furloughed indefinitely by order of General P. G. T. Beauregard. But in December of 1861 he was present for duty and on detached service at Manassas. He was a son of Robert Virginia. and Thursa Emerson of Anderson Dist. J. A. Smith died of disease in 1861 at Culpeper, Virginia. He was a member of Co. B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.).

James Andrew Monroe Smith enlisted as a first corporal in Co. D, 4th S. C. Volunteers (Inf.) at Anderson, SC, 14 April 1861; he was mustered into Confederate service at Columbia, SC, 7 June 1861. He was promoted to 5th sergeant between 31 October and 31 Dec. 1861.

James A. Snipes served in Co. I, 2nd S. C. Rifles (Moore's Regt.), C.S.A. On 30 Jan 1862, he enlisted in Co. G, S. C. Cavalry. He was a son of Matthew Snipes of Anderson Dist.

Lemuel Waddel Tribble was enrolled as a 3rd sergeant in Co. J, 4th S. C. Volunteers (Inf.), C.S.A., at Anderson, SC. Later, he was promoted to 3rd lieutenant.

S. M. Fant served in Co. B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.), C.S.A. He was discharged from the army during the Civil War. He had enlisted in the army at Anderson, SC, on 14 April 1861.

Hugh E. Erskine enlisted in Co. J, 4th S. C. Volunteers (Inf.) at Anderson, S. C. He was mustered into Confederate service at Columbia, SC, on 7 Jun 1861.

A. S. Evans was discharged for a disability from Co. F, 24th S. C. Volunteers (Inf.) in December 1861.

W. A. Maret was a member of the Palmetto Riflemen (Co. B, 4th S. C. Volunteers (Inf.), C. S. A. Jacob Alewine was a member of Co. I, 14th S. C. Volunteers.

James A. Alewine served in Co.

4th S. C. Volunteers (Inf.).

During the winter of 1861-62,
he was sick and in Warren

Springs Hospital by order of
the surgeon.

Tapley A. Anderson was a 5th sergeant in Co. K, 2nd S. C. Rifles (Moore's Regt.), C.S.A He was killed at Fort Harriso

Stephen A. Breazeale enlisted in Co. J. 4th S. C. Volunteers (Inf.) as a private at Anderson, SC, 14 April 1861. He was reported on his unit's Muster roll of 31 Aug 1861 as being on furlough for thirty days on business of the compa by order of the colonel.

Arthur W. Brock was enrolled as a private in Co. J, 4th S. C. Volunteers (Inf) at Anderson, SC, 14 April 1861.

J. T. Hanna was a private in Co F, 24th S. C. Volunteers (Inf

John Mauldin Manning was enroll ed as a private in Co. C, 4th S. C. Volunteers (Inf.) at Anderson, SC. He was promoted to 5th corporal on 31 Oct 1861.

John M. Elgin joined for duty a enrolled as a privete in Co. 4th S. C. Volunteers (Inf.) a Anderson, SC, 14 April 1861.

Andrew Wallace Elrod was born c 1817. He served in Co. B (Pa metto Riflemen), 4th S. C. Vo unteers (Inf.) and in Co. C, Palmetto Sharpshooters, C.S.A He was a grandson of John Swo Swords, Sr., a Revolutionary War veteran. Elrod's brother John Archibald Elrod, also se ved in the Confederate States Army during the Civil War. A drew Wallace Elrod was wounde at Wills Valley, Tennessee, but he survived the Civil War John Thomas Skelton was wounded furing the Civil War. He served to the rank of sergeant in Co. B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.), C.S.A.

Whit McCurry was a member of Co. I, 14th South Carolina Volunteers (Inf.), C.S.A.

George W. McDavid enlisted in Co. J, 4th S. C. Volunteers (Inf.) at Anderson, SC, 14 April 1861. He was mustered into Confederate serv. at Columbia, S. C. on 7 Jun 1861.

John T. Darlington was transferred to another command from Co. B, 4th S. C. Volunteers (Inf.).

George M. Bigby(1820-1889) was promoted from rank of sergeant to that oof lieutenant in Co. K, 1st S. C. Rifles (Orr's Regt.). He survived the war and was buried in 1889 at Honea Path Presbyterian Church in Anderson County, South Carolina.

Reuben Cox enlisted in Co. J, 4th S. C. Volunteers (Inf.) at Anderson, S. C. He was promoted to sergeant during the Civil War.


William Rufus McLees enrolled as a private in Co. C, 4th S. C. Volunteers (Inf.), C.S.A. In December 1861 he was reported as being on sick furlough.

James Thomas Martin was a member of Co. D, 4th S. C. Volunteers (Inf.) He was reported on his unit's roll of Oct. 31 to Dec. 31, 1861 as absent, sick, in hospital.

Sidney Pilgrim died of pneumonia at Leesburg, Virginia 5 July 1861. He was a member of Co. D, 4th S. C. Volunteers (Inf.), C.S.A.

Samuel David Shearer enlisted in Co. C, 4th S.C. Volunteers (Inf.) at Pendleton, SC, 14 April 1861. He was transferred to Co. F of the same regiment 3 June 1861.

John Thomas Ashley served in Co. E, 20th S. C. Volunteers, C.S.A.



Dillard J. Herndon was killed during the Civil War. He enlisted in the Confederate States Army at Anderson, S. C., 14 April 1861.

G. L. McGee was a first lieutenant in Co. F, 24th S. C. Volunteers (Inf.). He resigned in June 1862.

James A. McGee died of disease at Culpeper, Virginia, 7 Aug 1801. He enlisted at Anderson, S. C., 14 April 1861, and served in Company B (Palmetto Riflemen), 4th S. C. Volunteers (Inf.), C.S.A.

John M. Elgin of Anderson District, S. C., served in Co. J, 4th S. C. Volunteers (Inf.), C.S.A.

John William Ellis served in Co. E, 2nd S. C. Rifles (Moore's Regt.) (or possibly the 1st S. C. Rifles).

H. F. Moore was mortally wounded in battle at Jackson, Mississippi, in May 1863. He was a member of Co. F, 24th S. C. Volunteers (Inf.), C.S.A.

Newton Berry Jones served in Co. D, 4th S. C. Volunteers (Inf.)


Elihu Halbert Acker (1828-1865) served first as & 3rd lieutenant in Co. Gist Rifles; at the unit's reorganization 25 April 1862, he was elected 2nd lieutenant; wounded 31 May 1862 at the Battle of Seven Pines in Virginia: because of wounds he resigned 29 Sept 1862, but he re-entered the C.S.A. 31 Mar 1863; he died at Williamston, SC, shortly after the Civil War and was buried at Shady Grove Baptist Church near Belton in Anderson County, SC.

William W. Humphreys served to the rank of major in the C.S.A.; member of Co. B (Palmetto Riflemen), 4th S.C. Volunteers (Inf.). He survived the Civil War.

Co. B, 4th S.C. Volunteers (Inf.), C.S.A.




## Colonel Francis E. Harrison (1826-1878)

A native of Andersonville in Anderson District, South Carolina, this Confederate soldier served first as a captain and commanded Company D, 1st South Carolina Rifles (Orr's Regiment), C. S. A. He was wounded at Gaines' Milt, Virginia, June 29, 1862, and then personally excised a bullet from his leg. Later, he was promoted to major and then to fleutenant colonel. He was also appointed regimental commander. On May 2-4, 1863, his regiment participated in the Battle of Chancellorsville, a major engagement of the Civil War. He was promoted to colonel May 5, 1863.

- P. H. Pruitt was killed inside enemy lines at Franklin, Tennessee, 20 Nov 1864; he served in Co. F, 24th S.C. Volunteers (Inf.), C.S.A.
- G. Lucas King was killed at Petersburg, Virginia, 19 June 1864; he served as a private in Co. K, 2nd S.C. Rifles (Moore's Regiment), C.S.A.
- Augustus A. Dean (1842-1935) was buried at Cross Roads Baptist Church in Anderson County, SC; he was a Confederate soldier during the Civil War and a lifelong resident of the Starr community of Anderson Co., SC.
- W. C. Herndon served in Co. H, Palmetto Riflemen, 4th S.C. Volunteers (Inf.) and was killed in battle.
- James Crawford Keys (1813-1895) served in Co. C, 1st S.C. State Troops in 1863-64, despite his advanced years. After the Civil War, he was arrested by Federal officials and tried for the murders of three soldiers from the state of Maine who were members of a company of occupation troops in the Anderson area. The soldiers were killed at Brown's Ferry on the Savannah River. Keys was convicted by a military tribunal in Charleston and sentenced to death. On July 26, 1866, his death sentence was commuted to life in prison by U. S. President Andrew Johnson. Shortly thereafter, Keys was released by writ of habeas corpus and was never retried. Four of Keys' sons also served in the Confederate States Army.
- James Marshall Dunlap (1841-1932) enlisted in Co. K, 1st S.C. Rifles
  (Orr's Regiment) 20 July 1861; he
  served as regimental color bearer
  and was wounded six times during the
  war; he was promoted to fourth sgt.
  22 Apr 1863; his wife was Mary Ann
  (Cox) Dunlap; three of this soldier's
  brothers also served in the Confederate States Army.
- John Long served to rank of first lieut. in Co. D, 4th S.C. Volunteers (Inf.).
- S. H. Taylor was captured by Union troops at Missionary Ridge in Nov. 1863; he served in Co. F, 24th Regt.

- James A. Bigby (1831-1900) served in Co. K, 1st S.C. Rifles (Orr's) and survived the Civil War; he was buried at Honea Path Presbyterian Church in Anderson Co., SC.
- Benjamin Manuel Mitchell joined Co. D, 4th S.C. Volunteers (Inf.) at Anderson, SC, and was eventually promoted to second sergeant.
- John Robert Richey (1844-1862) died during the Civil War; he was a private in Co. D, 4th S.C. Volunteers (Inf.); he was buried at Fairview Methodist Church in northern Anderson County, SC.
- Henry J. Knauff of Pendleton, SC, served in Co. B, 4th S.C. Volunteers (Inf.); he was a son of William Knauff, a furniture maker who crafted a number of furnishings for the John C. Calhoun home on the Fort Hill plantation; after the Civil War, Henry J. Knauff went to Milam County, Texas, with his good friend Manson S. "Manse" Jolly, the ex-Confederate soldier who became known as the "unreconstructed rebel." Knauff later returned to South Carolina.
- Joseph Allen Laboon (1840-1906) was a member of Co. D, 4th S.C. Volunteers (Inf.), and he also served in Co. C, 4th S. C. Cavalry Regt. On June 10, 1863, he enlisted as a corporal in Co. B, 37th Bn. VA Cavalry; at the time of that enlistment, he was 23 years of age.
- H. Manley Darlington served in Co. B, 4th S.C. Volunteer (Inf.), and he died of disease while serving in the Confederate States Army.
- J. M. Hanks was a corporal in Co. E, 20th S. C. Regiment during the war.



- Thomas Jefferson Bratcher was enrolled as a private in Co. D, 4th S.C. Volunteers (Inf.) at Anderson, SC, 14 April 1861.
- William Felix Barr (1832-1895)
  joined for duty and enrolled in the Confederate States
  Army 31 May 1861; son of
  Leroy Barr (1804-1877) and
  Matilda Ann (Jones) Barr (1810-1851); two of his brothers also served in the Confederate Army and they were: Samuel Andrew Barr and John Milton Barr.
- Spencer Gregory died of disease in March 1864; he served in Co. K, 2nd S.C. Rifles (Moore's Regiment).
- John Lathan (b. ca 1820 d. 1907) served as a private in Co. E, 20th S.C. Infantry He was a hospital patient at Petersburg, Virginia, when he was discharged from the army 13 July 1864; he resided in Corner Township of Anderson District, SC.
- O. B. McAlister of Co. F, 24th S.C. Volunteers was killed in battle at Jackson, Missispi, in May 1863.
- John Baylis Lewis (1848-1929)
  served in 1st Regiment S.C.
  State Troops; he survived
  the Civil War and became a
  merchant in Belton (Anderson County), SC.
- J. Berry Holcomb served as a private in Co. K, 2nd S.C. Rifles (Moore's Regiment).
- Maddell Hillhouse taught school at White Rock before joining the Confederate Army; killed at the First Battle of Bull Run at Manassas, Virginia.
- J. A. Quailes enlisted in Co. D, 4th S.C. Volunteers (Inf.)

## TAKE NOTICE.

IN pursuance of Orders from the Adj't. & Inspector General's Office, I have been ordered to repair to Anderson District, for the purpose of arresting all men between the ages of 16 and 17 years, who have failed to report to their command, Co. "H.," 1st Regt. State Troops. I hereby warn all men liable to this call, between the ages of 16 and 17 years--all Teachers or School-masters under 40 years of age---all keepers of ferries, toll-bridges and toll grain mills, under the age of 45 years, as well as all exempts from Confederate service, to report to me forthwith at Anderson C. H., or they will positively be arrested and lodged in jail. Those persons who have already been warned by my detachment will report to me at Anderson C. H. on Saturday next, 18th inst.—failing to report then, they will do so on Monday next 20th inst.; or expect to be taken by force.

- James W. Stevenson (1838-1909) was the husband of Catherine (Ranson) Stevenson (1832-1908); he served in Co. D, 1st S.C. Artillery, C.S.A.; he was buried at Generostee ARP Church at Iva in Anderson County, SC.
- Josiah H. Stokes died of disease in May 1864 while serving in the Confederate States Army; he was a member of Company K, 2nd S.C. Rifles (Moore's Regiment), C.S.A.
- Enoch B. Rice served to rank of corporal in Co. B, 4th S.C. Volunteers (Inf.); his company was known as the Palmetto Riflemen. He survived the war
- G. W. Stone of Anderson District, SC, enlisted as a private in Co. D, 1st S. C. Inf. (Vol.) at Camp Pettus, Firginia, 1 August 1861.
- James N. Barker (d. Oct. 1864); a
  memorial marker at Good Hope Presbyterian Church in Anderson Co. contains the inscription "unknown
  grave."



- Preston Lewis Adams (1825-1906) enlisted in Co. F, 24th S.C. Volunteers (Inf.). His wife was Sarah Ann (Prince) Adams (1843-1925).
- Balie Barton Breazeale served to the rank of fourth sergeant in Co. J, 4th S.C. Volunteers (Inf.); he later served in Co. B, 37th Bn. Virginia Cavalry, in which he enlisted at Richmond, Virginia, 15 April 1862, at the age of 26 years
- John Franklin Clardy Joined Co. D, 4th S.C. Volunteers (Inf.) at Anderson, SC, 14 Apr 1861; he later enlisted in Co. B, 37th Bn. Virginia Cavalry at Richmond, VA.
- James S. Gambrell enrolled in Co. J, 4th S.C. Volunteers (Inf.) at Anderson, SC, 14 Apr 1861; he rose to rank of sixth corporal.
