Samuel Maverick Van Wyck was a general and staff surgeon in the Confederate States Army during the Civil War. He died November 30, 1861, at the age of 26 years. His Wife was Margaret (Broyles) Van Wyck (1834-1923). He was buried at Anderson First Presbyterian Church in Anderson, South Carolina.

> William A. Hopkins enlisted as a private in Company L, Palmetto Sharpshooters, C.S.A. He was wounded twice during the war. His disposition is unknown.

James A. McDavid served as a captain in Co. E, 2nd S. C. Rifles (Moore's Regt.).

Jesse McGee was discharged from Co. B, 4th S. C. Volunteers during the war.

Thomas Cox, a Confederate veteran, was born December 19, 1819, and died April 4, 1893. He was buried in Williamston Cemetery in Anderson County,

E. C. Prince was wounded at Jackson, Mississippi, in May 1863 and died in the summer of 1864. He was a private in Co. F, 24th S. C. Vol.

Lt. William J. Jones (1826-1895) Co. C, 4th S. C. Volunteers and Co. I, Hampton Legion, S. C. V. Confederate States Army (Drawing by Charles H. Busha) CONFEDERATE SOLDIERS OF ANDERSON DISTRICT, SOUTH CAROLINA

- John Taylor Hackett enlisted in the 4th S. C. Volunteers (Company B) at Anderson, S. C., on April 14, 1861; mustered into Confederate service at Columbia, S. C., on June 7, 1861. Reported on his unit's muster roll of December 31, 1861, as at general hospital.
- Alexander Haley served as a private in Co. K, 2nd S. C. Rifles (Moore's Regiment), C.S.A.
- William J. Haley served as a private in Co. K, 2nd S. C. Rifles (Moore's Regiment), C.S.A.
- Benjamin Franklin Mulligan (1833-1909) was a son of James Mulligan (1794-1888) and Malinda Norton Mulligan (1799-1889). He served in Co. D, 4th S. C. Volunteers (Sloan's Regt.) He was promoted to 3rd sergeant between October 31, 1861, and December 31, 1861.
- <u>Newton W. Parker</u> joined for duty and enrolled in Co. J, 4th S. C. Vol., C.S.A. at Anderson, S. C., on April 14, 1861. He was a private.
- W. Mc. Gordon was a private in Co. F, 24th S. C. Volunteers, C.S.A. He was discharged from the army because of a disability.
- James A. Darneld was promoted through ranks to second sergeant in Co. K, 2nd S. C. Rifles (Moore's Regt.), C.S.A. He was wounded at Gaines' Mill, Virginia, and was later killed in action at Fort Harrison (in 1864).
- Benjamin Sloan served as adjutant of the 1st South Carolina Rifles (Orr's Regiment), C.S.A. He was transferred to an artillery unit during the Civil War. His rank was major.
- B. F. Smith served as a private in Co. D (Gist Rifles), Hampton Legion, CSA.
- William M. Spearing died in the summer of 1863 while serving as a private in Co. F, 24th South Carolina Volunteers, C.S.A.
- James T. Todd served in Co. C, Palmetto Sharpshooters, C.S.A. He was

- mortally wounded on May 31, 1862, during the Battle of Seven Pines in Virginia.
- William Barr Todd (1845-1886) served in Co. E, 1st South Carolina Rifles (Orr's Regiment), C.S.A. His wife was Janie Frances (Harris) Todd (1849-1923), daughter of B. B. Harris of Oconee County, S. C. They were married on October 29, 1873.
- William John Vandiver (1843-1929) was a soldier during the Civil War. He married Nancy Lou Keaton of Anderson County, S. C., on November 25, 1869. He was buried in Old Silverbrook Cemetery in Anderson, S. C.

The Confederate soldier depicted above was buried at Sharon Methodist Church in northern Anderson County, South Carolina.

Needham K. Bryant served as a private in Co. D, 18th South Carolina Infantry

W. F. Bryant was a sergeant in Co. D, 18th South Carolina Infantry, C.S.A.

- Dudley C. Howard (1819-1886) served as a corporal in Co. C, 1st S. C. State Troops. His wife was Elizabeth Jane (Porter) Howard (1826-1902). They were married on Oct. 10, 1844. Dudley C. Howard was a son of Hiram Howard (1780-1866) and Sarah (Carter) Howard (1781-1863).
- L. C. Milford was mortally wounded in battle at Decatur, Georgia, on July 22, 1864. He was a private in Co. F, 24th South Carolina Volunteers.
- Jesse Miller was killed in action on June 30, 1862, while serving in Co. I, Palmetto Sharpshooters, C.S.A.

- William Rufus McLees joined for duty and enrolled in Co. C, 4th South Carolina Volunteers (Inf.), C.S.A. He was reported on his unit's roll of December 31, 1861, as on sick furlough.
- Daniel N. Major was a member of Co. J. 4th South Carolina Volunteers (Inf.), C.S.A. He was mustered into Confederate service at Columbia, S. C., on June 7, 1861.
- Peter Amai Murray was a private in Co. D and Co. K of the 3rd South Carolina Volunteers, C.S.A.
- C. P. Murrell served as a private in Co. D (Gist Rifles), Hampton Legion, South Carolina Volunteers, C.S.A.
- Benjamin F. Brown (1833-1919) served as surgeon of the 2nd South Carolina Rifles (Moore's Regiment), CSA. He survived the Civil War and was pardoned at Appomattox Court House, Virginia. He was a first cousin of Col. J. N. Brown of Anderson Dist., S. C. His wife was Sarah Patterson Wideman Brown (1838-1918). They were buried at Williamston Cemetery in Anderson County, South Carolina.
- L. M. Hall was wounded at Jackson, Mississippi, while serving as a private in Co. F, 24th South Carolina Volunteers (Inf.), C.S.A.
- <u>M. H. Hall</u> died in a Union prisonerof-war camp in 1864. As a member of Co. F, 24th South Carolina Volunteers, C.S.A., he was captured by enemy troops during the war.
- A. Clark Hallums, Jr. (b. ca 1840 d. 1861) was a son of A. C. Hallums, Sr. of Williamston, S. C. He was killed in action during the First Battle of Bull Run at Manassas, VA. His unit was Co. D (Gist Rifles), Hampton Legion, S.C.V., C.S.A. Before the war, he was an apprentice carpenter in Anderson District, SC.
- Hiram B. Major was a sergeant in Co. C, 1st South Carolina State Troops. He was a resident of Anderson Dist., South Carolina.

CONFEDERATE SOLDIERS OF ANDERSON DISTRICT, SOUTH CAROLINA

- Joseph P. Parker served as a sergeant in Company E, 20th South Carolina Volunteers (Inf.), C.S.A. In 1914, he attended a reunion of the Confederate military unit in which he served during the Civil War.
- Bird Phillips joined for duty and enrolled in Co. C, 4th S. C. Volunteers (Sloan's Regt.), C.S.A. He served on extra duty as company wagoner.
- W. L. Prince, a Confederate veteran, was buried in Williamston Cemetery in Anderson County, South Carolina.
- Samuel A. Purdy (b. ca 1843 d. 1936) enlisted in Company G, 1st South Carolina Rifles (Orr's Regt.) when he was seventeen years of age. He lived to be 93 years of age and died at his home in the Bowen School community of Anderson County, SC. He was survived by four children and was buried at Rocky River Baptist Church in Anderson County, SC.
- I. K. Rabb was a private in Co. D. (Gist Rifles), Hampton Legion, CSA.
- John Samuel Ragsdale served in Co. K, Ist South Carolina Rifles (Orr's Regiment), C.S.A.
- Thomas Cooper Martin (1830-1908) was a private in Co. D, 4th S. C. Volunteers (Inf.), C.S.A. He married Harriett Baker (1837-1906). They were buried in Old Silverbrook Cem. in Anderson, South Carolina.
- William Maxwell Martin (b. ca 1837 d. 1861) was 24 years of age when he died in Columbia, S. C., while serving in the Confederate States Army. He was a son of William and Margaret Martin of Anderson Dist., S. C. His paternal great grandfather fought in the Revolutionary War and commanded a company at the Battle of King's Mountain in 1780.
- James P. Cox served in Co. G, 2nd South Carolina Rifles (Moore's Regiment), C.S.A. He was promoted to the rank of corporal, then to sergeant and finally to lieutenant.

- Martin Davis served as a private in Co. C, 1st South Carolina State Troops.
- Abner H. McGee married Sallie M. Jones of Abbeville County, S. C., on Oct. 13, 1869. He was a veteran of the Civil War and was buried in Williamston Cemetery in Anderson County, SC.
- Park McJunkin was killed during the Civil War. He attended White Rock School before the conflict. (Was this soldier S. P. McJunkin, who served as a corporal in Co. B, Palmetto Sharpshooters and was killed in action on June 30, 1862, during the Battle of Frayser's Farm in VA?)



Taliaferro N. "Tally" Simpson, who is depicted above, was buried on the family's farm near Pendleton, S.



- John E. Wigginton was a sergeant in Co. D, 18th S.C. Regiment, C.S.A.
- Samuel M. Wilkes was adjutant of the 4th S. C. Volunteers (Sloan's Regt.) and was killed in 1861 during the First Battle of Bull Run (First Manassas) in Virginia. On Jan 18, 1902, his son, Samuel Wilkes, **Spoke to** the gathering at the dedication of the Confederate Monument in Anderson, S. C.
- J. B. Williams served as a private in Co. D (Oist Rifles), Hampton Legion, CSA.
- Samuel G. Williams (1844-1900) was a member of Co. L, 1st S. C. Rifles (Orr's). His wife was Sarah Jane Williams (1843-

1900). They were buried at St. Paul Methodist Church in Anderson Co., SC.

- Elijah Whitefield Stewart served in both Co. C, 4th S. C. Volunteers (Sloan's Regt.) and in Co. B, Palmetto Sharpshooters, C.S.A. He wounded twice during the war, which he survived. On January 30, 1873, he married Sallie P. McAlister in Anderson County, South Carolina.
- Garrison Timbs (Timms?) was wounded at the First Battle of Bull Run at Manassas, Virginia, in 1861. He was a private in Co. D (Gist Rifles), S.C.V., C.S.A.
- Harrison Tucker (1821-1902) and his wife, Mary A. (Watson) Tucker (1822-1907) were buried in Old Silverbrook Cemetery in Anderson, S. C. He was a Confederate soldier.
- Reuben Tucker was a member of Co. E, 2nd South Carolina Rifles (Moore's Regiment), C.S.A.

Davis Vanadore attended the 1914 re-

Sanford Vandiver Vaughn

was a private in Co. D, 1st South Carolina Rifles (Orr's), CSA.

David Lewis Wardlaw was born about 1825.

He was a private in Co. E, 16th South Carolina Infantry, C.S.A. He was a son of John Moore Wardlaw and Susan (Greer) Wardlaw. His wife was Georgean Wardlaw. He was a brother of Jesse Wardlaw, C.S.A.

Nesley Welborn, a Confederate soldier, was killed in action during the war. He was a resident of Williamston, South

Carolina (Anderson County).

- <u>A. L. Welch</u> married Mrs. H. J. Stone of Anderson County, S. C., on Dec. 17, 1874. He was born Sept 3, 1839, and died March 20, 1917. His wife, Hulda Jane Welch, was born in 1838 and died in 1912. They were buried in Old Silverbrook Cemetery in Anderson, SC.
- James Nathaniel Richey (1815-1894) enlisted in C.S.A. on August 1, 1863, and was discharged on a surgeon's certificate on Sept. 24, 1863, at Columbia, S. C. His wife was Emily (Kay) Richey (1821-1841). After her death, he married Lucinda Hunt (1814-1888). Later, he was married two more times. He was buried at Fairview Methodist Church, situated between Easley, S. C., and Pelser, S. C. (in Anderson County).
- William Asbury Al. en Rochester was a private in Co. C, 4th S. C. Volunteers (Sloan's Regt.), C.S.A. He was discharged from the Confederate States Army on December 9, 1861.

CONFEDERATE SOLDIERS OF ANDERSON DISTRICT, SOUTH CAROLINA

- W. A. Stewart, a private in Co. F, 24th South Carolina Volunteers (Inf.), C.S.A., was wounded slightly seven times, his skin being cut each time.
- Albert N. Stone was born about 1843. Herved in both Co. J, 4th S. C. Volunteers (Sloan's Regt.) and in Co. B, 37th Battalion Virginia Cavalry, C.S.A. He was 21 years of age when he joined the Virginia cavalry in Richmond.
- A. J. Stringer was wounded in action during the First Battle of Bull Run (First Manassas) in Virginia. He served in Co. D (Gist Rifles), Hampton Legion, S.C.V., C.S.A. He married Mary Eleanor Rice (1846-1873) on January 10, 1871.
- Press B. Suber was a member of Co. I, 14th South Carolina Volunteers, C.S.A. He attended the company's first reunion which was held on September 2, 1896, at the home of J. B. Moseley of Lowndesville, SC.
- John P. Sullivan served to the rank of sergeant in the C.S.A. He was a member of both Co. B (Palmetto Riflemen) and Co. C, Palmetto Sharpshooters, C.S.A. He was wounded once during the war and was paroled at Appomattox Court House, Virginia. On October 23, 1870, he married Li ie Vandiver, only daughter of Mrs. Nary E. Vandiver of Anderson, South Carolina.

R. S. Cheshire was promoted from corporal to captain in Co. K, 1st S. C. Rifles (Orr's Regiment), C.S.A. He replaced Capt. George W. Cox who was wounded during the Battle of Gaines' Mill in Virginia during the War Between the States,

<u>David Hill</u> served as a private in Company C,

1st South Carolina State Troops.

- <u>M. M. Manley (or Manly)</u> was a veteram of the Confederate States Army. He was buried in Williamston Cemetery in Anderson County, South Carolina.
- David Owens joined Co. D, 4th S. C. Volunteers, C.S.A. at Anderson, SC, on April 14, 1861. Later, he also served in Co. L, Palmetto Sharpshooters, C.S.A., in which he was a sergeant. He survived the war and was paroled at Appomattox Court House, Virg. a, on April 9, 1865.
- <u>W. B. Acker</u> was a private in Co. D (Gist Rifles), Hampton Legion, S.C. Volunteers, C.S.A.
- Richard Harrison Anderson (1829-1907) was a son of Dr. William Anderson and Mary (Hunter) Anderson. He was a grandson of the Revolutionary patriot James Anderson (1747-1813) and Agnes Craig Anderson. James Anderson was a brother of Colonel Robert Anderson (1741-1813), another Revolutionary War patriot and the namesake of Anderson County, South Carolina. Richard Harrison Anderson married Josephine Elvira McCann. They are buried in Old Silverbrook Cemetery in Anderson, South Carolina.
