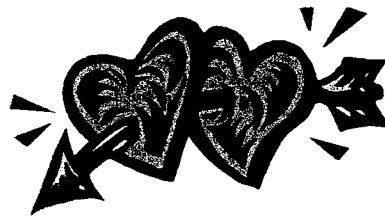

Minutes of January Meeting, January 6, 2003 The Anderson County Chapter of the SC Genealogical Society met at the Church of Jesus Christ of Latter Day Saints with 25 members and guests present. Ruth Cheney introduced a visitor, John Thirtle, who lives at Anderson Place. President Juanita Garrison called the meeting to order, and Chaplain, Lamar Gamble, gave the invocation. Minutes of the November and December meetings were read and approved. Ron Kay gave the treasurer's report. Balance on hand was \$13,272.37. Outstanding bills include a book we published and the postal box rental. We presently have 49 paid members. Ron reminded the group that dues are now due and payable for 2003. (\$13.00 individual member, \$16 family and \$10 associate)

The Chapter will give to Anderson County Library a microfilm in memory of Bobbie McGee Cochran, a member who died in December. This microfilm includes the Anderson Journal 1882-1889 as well as newspapers from Abbeville, Beaufort and Charleston. The newly published book, McDougald-Johnson Mortuary Index 1934-1952 is now available for \$10.00. Price approved by membership present.

The president then asked each of the officers to explain his or her duties to the group. It was suggested that Carolyn Duncan inquire about membership cards. It was seconded and passed. It was also suggested that our chapter do a workshop for beginning genealogists or to help list additional cemeteries. President Garrison asked for suggestions for program topics. John Denny Evans volunteered to help secure programs for the meetings. Details worked out. Video on family DNA tracing will be shown at next meeting. Meeting adjourned. Jean C. Minutes of the February meeting, February 3, 2003

With 26 members and guests present, President, Juanita Garrison called the meeting to order and the invocation given by Lamar Gamble. Thelma Wilson introduced two guests, her daughter-in-law Brenda Wilson and Dr. Hugh Vincent. Minutes of the January meeting were read and approved. The treasurer, Ron Kay, reported a balance of \$13,450.69 and a current membership of 75. It was reported that membership cards can be ordered from the state office and it was decided that the treasurer would order a hundred. A plea was sent out for members to submit materials for the Anderson Record. Committees were asked for reports. Pedigree sheets were distributed for corrections and additions. Dr. Charles Lee gave his report of the January SCGS Board Meeting in Columbia. Several changes have occurred that demand action. Since the Carolina Herald and Newsletter needs a new editor, every chapter has been asked to send one page per quarter to be published. Local Chapters must collect sales tax on items sold and report on a quarterly basis. The South Carolina Workshop will be held July 11-12 and each chapter will provide \$15 for the reception. Next meeting of the SCGS Board will be May 10. Motions were made to send money to the state board. Carolyn Duncan gave an interesting program on DNA testing with a demonstration by Ron Kay on how easy it is to get the DNA from your mouth. She said the research began at University of Arizona and was being promoted as "Family Tree DNA." We watched a video, "Genealogy by Genetics." Dr. Carl Ellison who has been linked to other branches of his family by DNA testing explained genetic markers. Meeting adjourned. Jean Martin, Recording Secretary
