
J. A. Verchot died on May 8th, 1957, and at the time of his death he was a resident of Abbeville, Abbeville County, South Carolina, and left a Last Will and Testement which has been probated in the Probate Court of Abbeville County, South Carolina, and a copy of said Will is actached hereto as Exhibit "A" and made a part hereof as though written herein.

The Executors of said Will as Louie P. Verchot, a brother, Ernestine German Nelson, a sister, Mary Nell Milstead Skelton, a niece, and T. A. Sherard, all of whom are over 21 years of age. These Executors were named in said Will and have been duly appointed by the Court where the Will was probated as such.

There has arisen some differences of opinion among the devices named in said Will as to its proper interpretation or construction, and likewise some differences of opinion have arisen among the devisees probably resulting from conflict of interests, and it is desired by the beneficiaries of said Will, as well as the Executors thereof, and it is desired by them advisable that some agreement be reached between them in reference to said estate and the division of the proceeds among those entitled thereto.

IT IS THEREUPON AGREED by Louis F. Verchot, individually, and as one of the Executors of said Will; Ernestine German Nelson, individually and as one of the Executors of said Will; Mary Nell Milstead Skelton, individually and as one of the Executors of said Will; T. A. Sherard as one of the Executors of said Will; Alphonse H. Verchot as one of the devisees of said Will; Albertine Verchot Green as one of the devisees of said Will; Helen Ruth Farr Hall as one of the devisees of said Will; Edward R. German as one of the devisees of said Will; and Elobe Milstead Williams as one of the devisees of said Will, as follows:

- 1. All the assets belonging to said J. A. Verchot at the time of his death, including the bonds not mentioned in the Will and which were issued to co-owners with him, are to be considered as assets of the estate.
- 2. That you'de F. Verchot, Ernestine German Nelson, and Mary Nell Milstead Skalten as Executors agree not to accept the Executor's



commission allowed them by law, conditioned upon this whole agreement being completed and executed, and that Mr. T. A. Sherard, one of the Executors, is to get the Executor's fee allowed by law, namely, one-fourth $(\frac{1}{4})$ of the fee allowed by law, which is $2\frac{1}{2}\%$ of all assets coming into the estate and $2\frac{1}{2}\%$ of all money and assets disbursed.

- 3.. All debts, income tax, federal estate tax, South Carolina estate and inheritance taxes, funeral expenses, the expenses incident to administering the estate, the bequest to the Verchot Cemetery, the bequest to the Baptist Church of Columbiana, and the bequest to the Methodist Church of Columbiana, are to be made first.
- 4. One-half interest in the home place of the late J. A. Verchot is, in accordance with the Will, to go to Mary Nell Milstead Skelton at the price of \$13,000.00. She is to pay her pro rata part of the expenses as outlined in item six (6) below.
- 5. The proceeds of the bonds, in the face amount of \$20,000.00 shown in the name of Joseph A. Verchot or Mrs. Helen Farr Hall, together with the \$3,000.00 as shown in the Will under Item Eight (8) is to go to Mrs. Hall. She is to pay her pro rate part of the expenses as set out in item six (6) below.
- 6. All expense including income taxes, estate taxes, and inheritance taxes are to be paid out of the remainder of the assets after adjustment of the bequests to Mrs. Skelton and Mrs. Hall. Mrs. Skelton is to pay her pro rata part of the expenses on the \$13,000.00 that the total taxes and expenses bear to the gross estate and Mrs. Hall is to bear her pro rata share of the taxes and expenses that the total taxes and expenses bear to the gross estate on her bequest of approximately \$23,000.00.
- 7. After all expenses have been paid, and after the amounts have been paid over to the cemetery, the Baptist Church of Columbiana, the Methodist Church of Columbiana, and the above net payments have been made to Mrs. Skelton and to Mrs. Hall, the residue is to be divided equally among the seven beneficiaries, namely: Louie F.
